GUIDANCE NOTICE



Scale G First Aid Kits

This Guidance Notice provides details of the medical supplies and equipment required under the National Standard for Commercial Vessels (NSCV) for the following vessel classes: 1D (with unberthed passengers), 1E (with unberthed passengers), 2D, 2E, 3D and 3E. A medical cabinet stocked with appropriate supplies may also be required.

This Guidance Notice is accurate as at 10 September 2014. Please check the current version of the NSCV and maritime legislation, or contact the National Regulator, to confirm current requirements.

Introduction

This Fact Sheet specifies the <u>minimum</u> medical supplies and equipment necessary to treat minor medical conditions or injuries, or to temporarily stabilise a patient until transfer to medical assistance can be arranged.

The supplies and quantities specified may need to be expanded in accordance with the particular risks inherent to the voyage, the length of the voyage, access to medical facilities, the cargoes carried, and the number of persons on board. Owners and operators should therefore obtain medical advice in specifying medical supplies for their vessels.

If you are unsure of the nature or seriousness of an illness or injury, radio medical advice should be sought and, if necessary, medical evacuation by helicopter should be initiated. If a child requires treatment, radio medical advice should be sought as the medical inventories are designed for adults.

Please note the following:

- Persons administering first aid should possess as a minimum a current first aid qualification in accordance with the NSCV Part D.
- Medical supplies must not exceed the expiry date specified by the manufacturer or supplier of the product.
- Products such as analgesics and creams will be considered adequate if an opened package contains at least 50 per cent of the original quantity, and the remaining product is uncontaminated and unaffected by any expiry date as a result of any seal being broken.
- Medication should be provided in original, sealed blister or foil packs where possible.
- All products must carry instructions and directions for use in English and clearly state the adult dose where applicable to enable safe and effective use of the medication for the intended purpose(s).

First Aid Kits

- All vessels must carry at least one portable first aid kit as specified in the table below.
- This kit must be located adjacent to the Master's accommodation, or in the wheelhouse. In small partly open vessels, the kit must be stowed so as to protect it from incoming spray and weather.
- The kit must be stored in a weather-tight, portable case of a non-corrosive material of suitable strength and size to accommodate the first aid stores. It should be fastened securely with quick-release closures.
- The kit must be labelled FIRST AID on the lid and at least 2 sides for quick identification. The storage location of the kit must be clearly identified with an appropriate sign or sticker.
- The kit must be cleaned and checked every 3 months.
